Elks National Foundation Scholarships

The Most Valuable Student - Submit by December 7, 2012

500 four-year scholarships, ranging from \$1,000 per year to \$15,000 per year, for graduating high school seniors based on financial need, leadership and scholarship. *Highlights:*

- The Elks National Foundation will award 500 four-year scholarships to the highest-rated applicants in the 2013 competition.
- Any high school senior who is a citizen of the United States is eligible to apply.
- Applicants need not be related to a member of the Elks.

Legacy Awards - Submit by noon (CST) February 1, 2013

\$4,000 (\$1,000 year for four years) merit-based scholarships for children and grandchildren of Elks who are members in good standing. *Highlights:*

- Any child or grandchild (or step-child, step-grandchild, or legal ward) of a living Elk who joined the order on or before April 1, 2010, or a charter member of a Lodge that was instituted on or after April 1, 2010, is eligible to apply. The Elk must also be a paid-up member through March 31, 2013. Great-grandchildren are not eligible.
- The applicant must be a high school senior.
- Must apply online only. Applications will be available ONLINE ONLY after September 1, 2012.
- If the applicant's parent and grandparent are both Elk members, the applicant must apply through the parent's Elks Lodge.
- Applicants must take the Scholastic Aptitude Test or the American College Test by December 31, 2012.

Emergency Educational Grants - New and renewal applications should be filed between July 1 and December 31 One-year educational grants available to children of deceased or totally disabled Elks. Highlights:

- The Elk parent or stepparent must have been a member in good standing for at least one year at the time of his or her death. **OR**
- The Elk parent or stepparent must have been a member in good standing for at least one year before he or she became totally disabled and must continue to be an Elk in good standing when application for assistance is made.
- The applicant must demonstrate financial need to qualify for a grant under this program.
- The applicant must be unmarried, under the age of 23 as of Dec. 31 in the year of application, and attending an accredited U.S. institution of higher learning as a full-time (12 semester hours) student.
